The particulars of the posts/eligibility etc. are detailed below:

1.	Under Institute Technician T-1	01 (UR)	Pay Level-3	The Officials appointed on DR in T-1, but subsequently promoted to higher grades on 5 yearly assessment basis will also be considered against T-1 vacancy.
2.	Under KVK, North Goa T-1 Driver	01 (ST)	Pay Level-3	Technical personnel holding analogous post of T-1 Driver with 05 years regular services (including two years of probation period on initial appointment in any ICAR or KVKs.

Eligibility Criteria:

- 1. The Technical personnel appointed in ICAR against the entry level post of Driver/Technician T-1 in Category-1 of TSR and having five years of regular service in the Pay level-3 of VII CPC.
- 2. The employees should have completed five years of regular service as on the date of calling of applications 10-10-2024, except in case where the request is being made on medical/working spouse grounds, etc.
- 3. The terms and conditions for inter-institutional transfer will be governed as laid down in the Council's letter No. 19(01)/2002-Estt.IV dated 19-03-2020 & TS-19(6)/2020-Estt.IV dated 19-03-2021.
- 4. The applicant applying for Technician T-1 post (sr. no.1) should have 5 years of experience as electrician.
- 5. The applicants, who have already applied, need not apply again.
