Terms and Conditions:

- 1. Candidates may choose to apply for more than one post if they meet the eligibility criteria for the posts. Accordingly, in the Application Form at Sr.No.1, candidates should tick the appropriate box (es) bearing serial numbers of the posts advertised as per the Notification F.No.I-19038/1/2020-Estt. dated 27-02-2021 avaiable on the website. It should be noted that only one application form is required to be filled even if the application is for more than one post. Further, only one set of application (marksheet, Degree certificates etc.) should be submitted to the Office even if the application is for more than one post.
- Duly-completed application form should be submitted in the proforma appended, accompanied with a latest passport-size photograph, self attested copies of: certificates for proof of age, educational qualifications, marksheets, degree certificate, experience, caste status(in case of SC/ST/OBC/EWS certificate issued by the Competent Authority in the prescribed form).
- 3. The prescribed qualifications are minimum. Where the number of applications received in response to advertisement is large, the Institute will restrict the number of candidates as per norms.
- 4. The Director, ICAR-CCARI, Goa reserves the right to shortlist the candidates for written test/interview, after due screening of applications, on the basis of qualifications, experience, etc.
- 5. The appointment of Young Professionals would be on full-time basis and she/he would not be permitted to take up any other assignment during the period of engagement with ICAR/ICAR Institutes.
- 6. The Institute shall have a pool of such manpower under the administrative control of the Director who shall assign the duties according to the requirements.
- 7. Notwithstanding the duration of engagement, the Director of the Institute can terminate the services of such staff at any time without assigning any reason by issuing one month's notice or on payment of one month's emolument by the young professional without assigning any reason by issuing one month's notice or on payment of one month's emolument by the young professional thereof.
