- 2. Duly-completed application form should be submitted in the proforma appended, accompanied with a latest passport-size photograph, self attested copies of : certificates for proof of age, educational qualifications, marksheets, degree certificate, experience, caste status(in case of SC/ST/OBC/EWS certificate issued by the Competent Authority in the prescribed form).
